Organizational Structure

Harvest Microschools Inc. is a registered nonprofit in the state of South Carolina, with federal 501(c)(3) tax-exempt status pending. The school operates under the name "Harvest Schoolhouse" through a licensing agreement with Harvest Schoolhouse LLC, which owns the proprietary educational model, curriculum, and brand assets. This structure allows us to maintain the creative, Christ-centered learning environment our families love while working toward eligibility for nonprofit educational funding and support.

Harvest Schoolhouse was originally founded as a privately operated microschool under Harvest Schoolhouse LLC and began on the campus of Cedarwood Church. In 2025, the program transitioned to nonprofit governance under Harvest Microschools Inc. While our current operations are based on the campus of New Journey Church in Greenwood, we are deeply grateful for the foundational support of Cedarwood Church and continue to value the lasting relationships formed there.

Harvest Microschools Inc. is also an approved Education Service Provider under South Carolina's Education Scholarship Trust Fund (ESTF) program.

STATEMENT OF FAITH

STATEMENT OF COOPERATION

Finances

We understand it is necessary that parents/guardians pay tuition for the amount stated in the tuition and financial information statement. If tuition payments and fees are not received within 10 days of the due date of each month, a \$30 late charge will be added each month to the account. *Tuition that becomes 30 days past due will result in the student being withheld from attending school until such amounts due are made current.* A fee of \$30 will be charged for each returned check. The full month tuition is due for any month in which the student attends one school day. All fees are due in full and are nonrefundable. Refunds are for tuition only, and will be made on accounts that are paid beyond the current month.

Tuition Assistance

Tuition assistance awards are based on the families demonstrated need as determined by an online application with a third-party vendor. The third-party agency makes financial needs assessments for the school. It uses information supplied by the applicant to assess financial need. Applications can be made online. Each award is made in the form of a discount on tuition, is for one year only based on availability of funds, and is awarded to returning families first. The deadline for initial applications each school year is June 30, 2025. Applications submitted after that date will be reviewed, and awards will be based on the amount of assistance remaining. *New students must be accepted by Harvest Schoolhouse prior to tuition assistance being requested.*

School Activities

We give permission for our child(ren) to take part in any and all school activities, field trips, including sports and school sponsored trips away from the school premises, and absolve the school from liabilities to us or our child, because of any injury to us or our child at school or during any school activity. In case of emergency or serious illness, we request the school to contact us first. If we are not available, please contact the designated emergency contact. If the emergency contact cannot be reached, the school has our permission to make whatever arrangements deemed necessary for our children's treatment. If the emergency is life-threatening, and we cannot be reached, the

physician has permission to act accordingly absolving the school of any liability. This statement of cooperation will serve as a blanket permission slip for the entirety of the current school year.

Volunteers

In order to help ensure the safety of our students, Harvest Schoolhouse has an established volunteer policy that is outlined in this School Handbook. We understand that in order to participate as a volunteer we will abide by the guidelines set forth in the volunteer policy and complete any necessary forms.

Privacy

Harvest Schoolhouse is committed to ensuring that your privacy is protected. Harvest Schoolhouse will use personal information, such as email, addresses and phone numbers, for school related, communication, inclusive of third-party services. Personal information will not be shared, sold, or distributed outside of this ministry. We likewise, authorize Harvest Schoolhouse, or anyone authorized by Harvest Schoolhouse, to use and reproduce all audio and videotapes and photographs, which Harvest Schoolhouse takes of our children or any family member produced for school, literature, advertisements, and promotional purposes without further compensation. All copies, masters, negatives, pictures, and proofs shall constitute Harvest Schoolhouse property, solely and completely.

Discipline

We believe discipline is a necessary aspect of our children's education. We give permission for our children's instructors, and or administrator to make, and enforce classroom regulations in a manner consistent with the school's community philosophy, and with Christian principles and discipline as set forth and scriptures. We understand that we have the responsibility to actively support the authority, philosophy, objectives, policies, procedures, and discipline of the school as established by the Head of School.

Parental Commitment

We understand that children are accepted on a general probationary status for the first 2 months. We agree that we will in no case complain to other parents, but will register only necessary complaints with the Head of School following the Matthew 18 principle. We pledge our full cooperation to keep doctrine controversy out of the school. We

agreed to support the school with our prayers and positive attitude. We understand that if at any time, the school determines, at its sole discretion, that our actions do not support the ministry, or reflect a lack of cooperation and commitment to the home and school working together, the school has the right to request the withdrawal of our child(ren). We understand that the school serves the right to dismiss our student for lack of cooperation on the part of the student, parent, and or guardian.

Admission to Harvest Schoolhouse is a privilege and not a right. It is a privilege granted, with the understanding that all students will desire to live as Bible-believing, consecrated Christians. Conduct exemplary of developing young Christians is expected. Drinking alcoholic beverages, using marijuana or other illegal drugs, smoking, profanity, disrespect for authority and property, improper sexual behavior, and abuse of others are prohibited. This applies to school, and non-school related social activities where unacceptable behavior would have an adverse effect on the testimony of the school.

School Overview

Harvest Schoolhouse is a small private Christian school, located on the campus of New Journey Church in Greenwood, South Carolina. Harvest Schoolhouse welcomes all students and families. It does not discriminate on the basis of race, color, national and ethnic origin in administration of its educational policies, admissions policies, scholarship and loan programs, and athletic and other school-administered programs.

At Harvest Schoolhouse, we are more than just educators; we are guides on a faith-based journey of self-discovery and transformation. Inspired by innovative learning models and Biblical principles, our school is a place where students navigate their paths with autonomy and creativity. With a blend of individualized/self-directed learning, multi-age groupings, and cutting-edge resources, we equip students to thrive in a rapidly evolving world. Harvest Schoolhouse is committed to Christian values, hands-on learning, and fostering a tightly bound community of compassionate leaders ready to impact the world.

Curriculum

Harvest Schoolhouse is a Christian school with daily worship, Bible study, and integration of Christian principles throughout the curriculum. We employ a blended

learning approach, focused on individualization, community and core skills. We foster mastery of core skills at an independent pace using individual instruction, hands-on application, and cutting-edge adaptive software programs. We offer various programs to track individual progress. Academic skills are integrated and practiced through thematic units, challenges, games, literature exploration, and purposeful daily writing.

The school year is broken up into thematic units. At the end of each unit, students participate in a culminating event to exhibit their work. Themes and events will be communicated to families throughout the year.

Extracurricular Activities

Students will have opportunities to engage in a variety of extracurricular activities, educational field trips, apprenticeships, artistic pursuits, trades and crafts.

Staffing Ratios

The number of enrolled students will not exceed the school's ability to employ qualified staff at a ratio of 12 students per staff member; however, two or more staff members will always be present for safety reasons.

Minimum Student Qualifications

Students must be able to work safely and independently on projects and academic tasks with minimal adult intervention. The admissions process will include a formal application, review of pertinent school records, a family and child interview, and a school visit. A school admissions committee will review and approve all enrollment decisions. Harvest Schoolhouse does not discriminate on the basis of race, color, national and ethnic origin in administration of its educational policies, admissions policies, scholarship and loan programs, and athletic and other school-administered programs.

Homework

A meta-analysis of more than 180 studies on homework and its effects demonstrated no correlation to achievement for elementary school, moderate correlation in middle school, and a counter-productive impact of too much homework in high school (Cooper, 2006). At Harvest Schoolhouse, the majority of school work and learning tasks can be completed during the school day.

Occasionally, students may need extra time beyond the regular school day to catch up on assignments or projects with a specific deadline, i.e. a project for an end-of-unit event. Students may also choose to login on their online core-skills programs outside of the regular school day, to accelerate their own progress or to meet personal goals. Otherwise we encourage students to spend their time at home engaging with their family and friends, reading, exploring hobbies, developing real-world skills, exploring the outdoors, playing, and participating in regular church activities.

Technology and Materials

Students will need a laptop or tablet at school each day. The school will provide a refurbished macbook laptop for each student. Students are encouraged to bring their own headphones and mouse for use with their school computer. School computers will not be taken home unless arrangements are made between the family and the Head of School for unique circumstances, i.e. extended medical absence.

Reading, writing and various art materials will be provided by the school. If a student wishes to utilize his/her own materials, such as specific pencils, crayons, markers or other school supplies, they can be brought to school and kept in the student's personal backpack.

Each student will need to bring a backpack to leave at school. In the backpack, students may store personal school supplies and other personal items. The school cannot ensure the safety of expensive items or devices such as cell phones, etc. It is recommended that those items be left at home. Students may choose to keep a small TSA approved luggage lock on his/her backpack, the Harvest Schoolhouse Head of School may open a student's backpack, or request that it be opened, if necessary for the investigation of specific incidents.

Harvest Schoolhouse engages in a lot of outdoor play and activities. student's may want to keep a "just in case" spare change of clothes in their backpack.

Grading and Report Cards

Student work is assessed through adaptive software score reports, quarterly skills assessments, learning portfolios, project and participation rubrics, etc. Reports will be sent home to parents at the end of each 9-week quarter. For upper grade level students

who require appropriately documented course grades for transcripts, letter grades will be given (A=90-100, B=80-89, C=70-79, D=60-69, F= 59 and below). Individual students who wish to pursue advanced classes will receive support to explore and enroll in various accredited online classes or to pursue dual enrollment in upper grades. For standard classes, the maximum grade point average (GPA) will be 4.0, advanced or honors class GPA maximum is 4.5, and dual enrollment class GPA maximum is 5.0. Course credit consists of 120 instructional hours. South Carolina high school graduation requirements can be found on the South Carolina Department of Education [website](#).

Exams and Assessment

Where appropriate for credit and transcript purposes, high school students may be given access to end-of-course exams to demonstrate mastery of concepts. Various assessments and exams are also built-in to the adaptive learning software used daily. State Standardized tests are not required for private schools, but Harvest Schoolhouse may utilize annual Spring standardized testing as a measure of student achievement in core subject areas, and can assist older students in preparing for, registering for, and taking college placement exams as needed.

Attendance

SC Code of Law 59-65-10, the South Carolina Compulsory Attendance Law requires that a parent or guardian shall require his child to attend regularly a public or private school or kindergarten of this State which has been approved by the State Board of Education, a member school of the South Carolina Independent Schools and Association, a member school of the South Carolina Association of Christian Schools, or some similar organization, or a parochial, denominational, or church-related school, or other programs which have been approved by the State Board of Education from the school year in which the child is five years of age before September first until the child is seventeen. Students must be present for 50% of the school day to be counted as present for the day.

Absence is considered excused with a written note from a parent or a parent phone call to the school. Given the blended learning approach to the Harvest Schoolhouse curriculum, students will have a variety of options for making up absences, or completing remote learning activities to satisfy instructional requirements. Students and

parents should communicate any pre-planned absences to the school, so arrangements can be made to complete instructional activities.

Absences are considered chronic when any student who misses 50 percent or more of the instructional day for any reason for 10 percent (or more) of the enrollment period. A school year at Harvest Schoolhouse consists of 159 days, at 7.5 hours per day, for a total of 1,192.5 hours of instructional hours during the annual enrollment period. Chronic absence would equate to missing more than 50% of the day for more than 15 school days. Excessive absences due to special circumstances (i.e. hospitalization due to illness, death in the immediate family) will be reviewed by the head of school and handled on a case by case basis. If a student is absent for 10 consecutive days with no communication from the family, the school reserves the right to administratively withdraw the student.

Truancy occurs when a student is “unlawfully” absent without the knowledge of his or her parents, or absent without acceptable cause with the knowledge of his or her parent, three consecutive days or a total of 5 days.

In instances of chronic absence and truancy, the school will meet with the parents to review whether or not the student continues to be a good fit for enrollment at Harvest Schoolhouse.

Inclement Weather

In the event of severe weather conditions, Harvest Schoolhouse may close or delay opening to facilitate safe travel. In most cases, Harvest Schoolhouse will follow the closure practices of Laurens County. Harvest Schoolhouse will communicate closures with parents via text alert or phone call.

School Hours

Doors open at 7:45 a.m. and students must be picked up by 4:30 pm.
student hours are 8:00 a.m. to 4:00 p.m.
Staff hours are 7:30 a.m. to 4:30 p.m.

Students must remain in their car with their parent(s) until the doors open at 7:45 a.m. All students must be picked up no later than 4:30 p.m. Parents will be assessed a late pick-up fee of \$5 for every 10 minutes after 5:00 p.m.

Daily Schedule

We frequently adjust the daily schedule to meet the needs of our students, and to accommodate current projects. For a copy of the most recent daily routine, please contact the Head of School.

Lunch, Wellness and Nutrition

We promote a culture of wellness and healthy living at Harvest Schoolhouse. Students are encouraged to make nutritious food choices and engage in regular physical activity. We do not operate a cafeteria. We encourage students to bring a healthy lunch and any desired snacks. Although we do have a specific lunch period every day, and we encourage healthy eating routines, students are permitted to eat when they are hungry, and drink when they are thirsty, and use the restroom when they need to. Each student should also bring a refillable water bottle for use throughout the day. The school has limited refrigerator and freezer space available to store perishable lunch items, a lunch bag with an ice pack is preferred. There is a microwave available for heating food.

Students may keep non-perishable back-up lunch and items at the school for days when they want or need additional food. If a student forgets his or her lunch, the parents will be notified. The school will also have some basic lunch and snack items on hand for the occasional forgotten lunch. We will never allow a student to go hungry.

Safety and Security

Student safety is our top priority. Harvest Schoolhouse maintains a secure campus. All exterior entrances are locked during school hours. When activities occur outdoors or in multiple buildings, staff will be in constant communication. Regular fire, evacuation and lockdown drills will be conducted. The campus is outfitted with security cameras and arrangements will be made with local authorities to ensure a rapid response should any unforeseen safety issue arise. Should evacuation be necessary, students will be transported to an established secure emergency evacuation site for parent pick up.

Visitors

Parents will be given specific procedures for gaining access to the school building via the main entrance. Visitors are only permitted by appointment. Visitors must present proof of appointment (e.g., email confirmation from the head of school, an instructor, or ministry staff) and valid ID before signing in to enter the school building. Parents may not enter the school through any entrance other than the main entrance. To pick up a student from school outside of regular pick-up time, parents or authorized individuals must present valid ID and sign the student out at the main entrance. Individuals not listed on the student pick-up form by the parents will not be permitted to pick up any student. ID must be verified at time of pick up.

Volunteers

All volunteers and substitute instructors must undergo a background check. Guest speakers or instructors will not undergo formal background checks, but will never be permitted to be alone with students. All volunteers will be scheduled by the Head of School to participate in activities that align with the school curriculum. The only exception to the background check and scheduling requirements will be volunteers and individuals attending or participating in public events hosted by the school.

Communications

It is our goal to provide your family as much information on school policies, procedures and daily activities as possible. To that end:

- Parents can email the Head of School at harvestschoolhouse@pm.me with non-urgent questions or concerns. Emails will be generally returned within 1 business day.
- Parents may text or call the Head of School at 864-993-1236 and/or instructors for day to day communications and notification.
- The school will utilize the Class Dojo app for parent communication and information sharing. Urgent information will also go out via text message or phone call.

Harvest Schoolhouse Publications and Media Communications

Any communications, written or oral, that are intended for distribution to the entire school community, the general public, or media organizations must be approved by or come directly from the Head of School. All details must be coordinated and approved

before any announcements are made. All media requests (newspaper, TV, radio, etc.) must be referred to the Head of School. The Head of School or the Head of School's designee is assigned as the only spokesperson for Harvest Schoolhouse in media inquiries.

Library

The school is actively building a school library. Instructors and the Head of School will assist students accessing online public library catalogs and borrowing desired books. Families are encouraged to plan family and friend library visits and used book sale outings on Fridays and weekends.

Off Campus Travel & Student Transportation

School staff will notify families in advance of any planned off-campus activities. Transportation for school-sponsored events may be provided, in full compliance with all applicable state regulations, once the school obtains a qualified vehicle and driver. Until that time, off campus trips will be arranged as optional family meet up opportunities. School staff members are strictly prohibited from transporting students in their personal vehicles.

Parents, volunteers, or parent-staff members may independently arrange carpools or transportation with other families. Such arrangements are made solely at the discretion of the individuals involved and are not coordinated, endorsed, or facilitated by Harvest Schoolhouse. In these cases, the parent, volunteer, or parent-staff member acts in a personal capacity outside of school hours. No agreements may be entered into with organizations that would compromise the school's operations or conflict with its Christian beliefs and educational philosophy.

STUDENT LIFE

Standards of Conduct

All students are expected to adhere to the school's standards of conduct, which promote respect, responsibility, and kindness. Behavior that goes against these values will be addressed promptly and constructively.

Dress Code

Our dress code promotes a neat and modest appearance. Students are expected to dress appropriately for a learning environment, including outdoor activities, with a focus on comfort and modesty.

Behavior Expectations

Harvest Schoolhouse is committed to cultivating a safe, Christ-centered environment where students feel secure, valued, and respected. We maintain a zero tolerance policy for intentional acts of violence, serious verbal aggression, and bullying. These behaviors violate our standards of conduct and Christian principles of love, self-control, and peacemaking.

Zero Tolerance Behaviors

Acts of violence include—but are not limited to—deliberate physical aggression such as hitting, punching, slapping, kicking, biting, or throwing objects with intent to harm, as well as threats of physical harm. Serious verbal aggression may include persistent name-calling, insults, intimidation, or threats intended to cause emotional harm or provoke a physical reaction. Bullying refers to repeated behavior that targets another student with the intent to harass, isolate, demean, or control.

We understand that children occasionally have disagreements or physical interactions during play. Minor playground squabbles, accidental bumps, or developmentally typical frustration will be addressed with redirection and restorative guidance—not punitive measures. However, when a student crosses the line into intentional harm—physical or emotional—it will be taken seriously.

If such incidents occur:

- The student(s) involved will be immediately separated from the group
- A staff member will provide supervision and support to all affected students
- The incident will be formally documented
- Parents of all involved students will be contacted
- If a student is physically hurt or emotionally harmed, communication with families and documentation are required
- A parent meeting will be held before the student may return to class

Further consequences—including suspension or dismissal—may be considered in the event of repeated or severe behavior.

As a Christian learning community, we aim not only to discipline but to disciple. We believe that children can grow through correction when it is rooted in love and truth (Proverbs 3:11–12, Galatians 6:1, Matthew 5:9). Our goal is to teach students how to pursue peace, restore broken relationships, and take responsibility for their actions.

Chronic Disruptive Behavior

At Harvest Schoolhouse, we value each child as a unique creation of God and strive to provide a nurturing environment where all students can thrive. However, when a student exhibits ongoing disruptive behavior that significantly interferes with the learning environment or consistently prevents others from engaging in their education, it may indicate a need for additional support or a different setting. In such cases, we will partner with the student's family to develop and implement behavior strategies with the goal of helping the student succeed within our model. If, after reasonable efforts, the

behavior persists and the student is unable to function effectively in our learning environment, we may recommend an alternative educational placement that better meets the child's needs. This decision is always made prayerfully, in love, and with the best interest of both the individual student and the broader school community in mind.

Attendance and Absences

Regular attendance is crucial for academic success. Parents/guardians are asked to notify the school in a timely manner if their child will be absent, either by phone, text, or email. For most absences, no written excuse is required. However, in the event of prolonged or recurring absences, the Head of School may request documentation to support appropriate attendance tracking. Communication and collaboration between families and school staff ensure flexibility while meeting legal and instructional requirements.

Assignments

Assignments are designed to reinforce classroom learning and develop independent study skills. Students are expected to complete assignments on time and to the best of their ability.

Assessment and Grading

Students are assessed through a variety of methods, including adaptive software, participation points, tests, projects, presentations, and discussions. Grades are based on academic performance, effort, and participation.

Acceptable Use Policy

TUITION & FINANCIAL INFORMATION

Tuition and Fees

Annual tuition at Harvest Microschools Inc., operating as Harvest Schoolhouse, is \$6,500 per student.

Each student is also assessed a \$1,000 Curriculum & Technology Fee, which includes:

- Curriculum Fee (\$500): Covers books, printed materials, consumables, and digital curriculum resources.
- Technology Fee (\$500): Covers a refurbished MacBook laptop and subscriptions to educational software and applications. All students are required to use a school-provided laptop.

Note: Students with a school-issued laptop from a previous year that remains functional and compatible with current programs will receive a discounted Technology Fee.

Payment Schedule Options

Families may choose one of the following payment plans:

Option 1 – Full Payment

- Pay \$7,500 (tuition + fees) in full, due one week before the student's first day of school.

Option 2 – Monthly Payment Plan

- Initial Payment: \$1,550 due at registration (\$550 tuition + \$1,000 fees)
- Remaining Payments: \$550/month, due on the 1st of each month, August through June (11 payments)

Families interested in quarterly or bi-monthly payment arrangements may speak with the Head of School to explore available options.

Payments may be made by cash, check, or recurring bank transfers. Online payments may incur processing fees. Mid-year enrollments will be prorated based on the number of weeks remaining.

Hardship Clause: Families unable to pay the full Curriculum & Technology Fee at registration may request to divide the fee into smaller installments. Requests must be submitted in writing and approved by the Head of School. Full payment must be made by the end of the first semester.

For ESTF Scholarship Recipients

Harvest Microschools Inc. is an approved Education Service Provider (ESP) under South Carolina's Education Scholarship Trust Fund (ESTF) program.

- The school will issue quarterly invoices
- Parents/guardians are responsible for uploading each invoice to their ClassWallet account
- ClassWallet will pay the school directly once the invoice is approved

If the parent fails to upload an invoice or funds are not released through ClassWallet, the parent/guardian is responsible for paying the tuition amount directly to the school.

Tuition Assistance

Need-based tuition assistance is available through an independent third-party application.

- Valid for one school year, with priority given to returning families

The deadline for initial applications is June 30. Late applications may be considered based on available funds. New students must be accepted before applying.

Note: Families who do not qualify for tuition assistance based on financial need but are experiencing temporary or unique financial hardship may still approach the Head of School to request limited support toward fees or one-time costs. These requests will be evaluated case by case, depending on the availability of funds.

Withdrawal Fee

A \$500 withdrawal fee will be charged for any student who withdraws between the first day of school and April 30.

- The full month's tuition is due for any month in which the student attends at least one day
- All fees are non-refundable
- Refunds apply only to tuition paid in advance beyond the current month
- Records (transcripts, report cards, etc.) will not be released until the account is paid in full

After-Care

Harvest Schoolhouse does not currently offer after-school or Friday care.

If there is sufficient interest, leadership may consider offering an After-Care program at an additional cost.
